Dear Tucker Maxon School community,

Happy 70th Anniversary! We had another very successful year in 2016–17. We had 110 students, with 39 children who are deaf and 71 children with typical hearing. We started the fiscal year with another successful 7 weeks of Tucker Arts Camp over the summer. We added new staff including Philip Banks, Mary DiPrete, Jennifer Hoofard, Mel Hordynski, Mary Roach, and Sara Rhoades. We strengthened our Board with the addition of Jim Kean, the father of one of our students. Rob Boley retired from the Board after more than 20 years of volunteer service. Tucker Maxon was also named to the Top 100 Nonprofits in Oregon list for the second time in our history.

There were too many highlights to list (see page 12) but here are some of our favorites. Parent volunteer and veterinarian Jordan Nuccio created an animal science program and by spring, baby chicks were hatching in classrooms. We also added 4 Nigerian dwarf goats to the menagerie. Care Oregon helped us purchase an Auditory Brainstem Response device to test the hearing of newborns and Rotary helped us purchase a pediatric tympanometer. Students raised nearly \$600 for Hurricane Matthew relief. Despite eight snow/ice days off over winter, students completed a month-long deep dive into everything Mexico for our annual cultural studies.

Staff and Board began a 10-month program evaluation called Project Impact. We also had a successful year of fundraising starting with the Maui raffle that raised \$25,500 and ending with a record-breaking gala auction that raised \$174,544. That night was also the world-premiere of our new video about the school "Where Every Child Has a Voice." We ended the year with a visit by Trailblazers' mascot Blaze and started work on our new treehouse classroom.

What a year! Thank you for all of your generous support.




