



# Tucker Maxon School

Annual Report 2017-18


Dear Tucker Maxon School community,

We had another very successful year in 2017–18. We had 106 students, with 41 children who are deaf and 65 children with typical hearing. We started the fiscal year with 8 weeks of Tucker Arts Camp over the summer with over half the weeks sold out. We added new staff including Orhan Belding, Sam Bouchillon, Nicole Miller, Mariah Morris, and Tracie Moyer. John Warwick retired from the Board after more than 24 years of volunteer service. Executive Director Glen Gilbert renewed his agreement to lead the school for another three years. Tucker Maxon was also named to the Top 100 Nonprofits in Oregon list for the third time in the last four years.

There were too many highlights to list (see last pg) but here are some of our favorites: Murdock Trust awarded us \$185,000 for a new Community Gift Officer. Our alumni survey showed 87% of alums go to college. The premiere of the film *Wondertstruck* at the Hollywood Theater raised over \$10,000 for the school. A Trailblazer's Commercial featured TMS kids. Board member John Lenz raised \$5,000 for us on his 60th birthday. Cultural Studies focused on South Korea. *Annyeonghaseyo!* We added ASL, chess and art to our after school programs. Four new trees were planted on the playground on Arbor Day, and we added eight new raised garden beds. Chicks hatched in every elementary classroom, bringing new life to the school.

The staff and Board completed a 12-month program evaluation called Project Impact. We also had a successful year of fundraising, starting with the Maui raffle that raised \$23,000 and ending with a very successful *Fiesta de Tucker* auction that raised \$162,321. Parent Tim Hadden told the story of his family moving from Alabama to Portland so his two sons could attend Tucker Maxon. We ended the year with a ribbon cutting ceremony for 128 new solar panels on the roof. Here comes the sun...




